ORDINANCE NO. 22- 003

AN ORDINANCE OF THE CITY OF WRIGHTSVILLE, ARKANSAS TO ABOLISH THE DEPARTMENT OF DISTRICT COURT OF THE CITY OF WRIGHTSVILLE, ARKANSAS, AND PROVIDING FOR THE FOLLOWING: A SEVERABILITY CLAUSE; EFFECTIVE DATE; PROPER NOTICE; OPEN MEETING; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Wrightsville, Arkansas is a city of the second class in the state of Arkansas and located in the County of Pulaski; and

WHEREAS, Section 19 of Amendment 80 to the Arkansas Constitution provided that all municipal courts were to become district courts on January 1, 2005, and that they should assume the jurisdiction previously vested in municipal courts, corporation courts, police courts, justice of the peace, and courts of common pleas. These courts shall continue in existence unless such City Court is abolished by the governing body of the city or by appropriate action of the General Assembly; and

WHEREAS, a town or city that prior to January 1, 2012 operated a municipal court that becomes a department of a district court may by ordinance of the town or city in which the department is located abolish the department of district court; and

WHEREAS, the District Court of Wrightsville has become a financial burden on the City of Wrightsville and the court not being an intangible asset to the City; and

WHEREAS, the Arkansas Code Annotated § 16-17-1202 states:

(d)(1)(A) A town or city prior to January 1, 2012, operated a city court that becomes a department of a district court may by ordinance of the town or city in which the department is located abolish the department of district court.

(B) A copy of the ordinance abolishing the department of a district court shall be sent to the Administrative Office of the Courts.

(2)(A) On and after the effective date of the ordinance abolishing the department of a district court, the nearest district court in the county shall be regarded as a continuation of the department of district court that was abolished.

(B) All papers and records pertaining to a department of a district court abolished by ordinance shall be transferred to the appropriate district court, and no suit or prosecution of any kind or nature shall abate because of any change made by this subchapter.

(C) Except as modified in accordance with this subchapter, any of the following existing on the effective date of the ordinance abolishing the department of a district court shall continue unaffected:

- (i) A writ;
- (ii) An action;
- (iii) A suit;
- (iv) A proceeding;
- (v) Civil liability;
- (vi) Criminal liability;
- (vii) A prosecution;
- (viii) A judgment;
- (ix) A decree;
- (x) An order;
- (xi) A sentence;
- (xii) A regulation;
- (xiii) A cause of action; and
- (xiv) An appeal.

(e) No town or city shall have the authority to reinstate a department of district court abolished by ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF WRIGHTSVILLE, ARKANSAS;

SECTION 1. The Department of District Court in the city of Wrightsville, Arkansas is hereby abolished.

SECTION 2. It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance be severable, and if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutional declaration shall not affect any remaining phrases, clauses, sentences, paragraphs or sections of this Ordinance, and the remainder of this Ordinance shall be enforced as written.

SECTION 3. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required and the public notice of time and place of meeting was posted as required by law.

SECTION 4. REPEAL. ALL Ordinances and or Resolutions in conflict herewith are specifically repealed.

SECTION 5. EMERGENCY CLAUSE. The City Council of the City of Wrightsville, Arkansas finds and determines that an Ordinance to abolish the Department of District Court In Wrightsville, Arkansas is necessary for the orderly administration and operation of the City of Wrightsville, Arkansas; an emergency is declared to exist and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in force and effect on and after the 11th day of March, 2022.



**Specialty Court Programs
Pulaski County Mental Health Court
Little Rock District Court**

The following Specialty Court Program is provided:

- a. **Type of Program and Description of Operations:** Pulaski County Mental Health Court-Little Rock is a voluntary, post-adjudication, highly intensive supervision program designed to address the needs of high risk/high needs persons with a mental illness or co-occurring disorder with current misdemeanor criminal cases. Mental Health Court is available only to defendants meeting program eligibility requirements; the defendant must be an adult resident of Pulaski County, having no unresolved felony offenses or active offenses. Mental Health Court is a minimum of twelve (12) months. Mental Health Court is held the second and fourth Thursday of each month at 2:30 p.m., at Little Rock District Court-1st Div. Criminal, 600 W. Markham, Little Rock, AR.

Admission to the Mental Health Court is completed in a series of steps:

Step One: Application- If the defendant meets the above criteria, he/she or defense counsel may make a request for a referral to Mental Health Court, which then must be submitted to the Prosecuting Attorney's Office. Speedy trial will be tolled during the entire process.

Step Two: Preliminary Approval- After the request is submitted to the Prosecuting Attorney's Office, the Deputy Prosecuting Attorney will review the pending charges and criminal history. If the Deputy Prosecuting attorney determines that the defendant's request should be considered for further review and approved, the defendant will be scheduled for an assessment.

Step Three: Probation Assessment- An assessment will be administered by the Probation Officer to determine the defendants' risk and needs. The Probation Officer will schedule a subsequent assessment with a Mental Health treatment Provider.

Step Four: Mental Health Assessment- Another assessment will be administered by a Mental Health Treatment Provider in order to determine clinical appropriateness for the program. Entry into Mental Health Court is usually limited to those who are determined as high risk/high needs and meet program criteria.

Step Five: Mental Health Court Team Review- After the completion of the assessments, the probation officer and treatment providers will share the information with the Mental Health Court Team for a final review.

Step Six: Plea-If the defendants request is approved by the Mental Health Court Team, he/she will be provided a date for acceptance of plea before the Mental Health Court Judge. Prior to the court date, the defendant must make an appointment with defense counsel to complete all necessary forms.

Step Seven: Sentencing- The defendant will appear at a hearing before the Mental Health Court Judge to be formally accepted into Mental Health court.


Statutory Authority: Pulaski County Mental Health Court- Little Rock was established pursuant to the Arkansas Code Annotated §16-100-101 and Arkansas Code Annotated §16-100-201, et seq.

Pursuant to Arkansas Code Annotated 16-100-204 (b)(2), the administrative plan for the judicial circuit may designate a district court judge to administer the mental health specialty court program if a judicial district does not have a circuit judge who is available to administer the mental health specialty court program on a consistent basis.


- b. **Certification of Compliance:** Pulaski County Mental Health Court-Little Rock operates in compliance with all applicable sentencing laws. This includes fines, court costs, fees, probation assessments, and sentencing alternatives.
- c. **Use of Court Resources:** The Pulaski County Mental Health Court-Little Rock team includes one (1) full-time District Judge, (1) full-time Deputy Prosecuting Attorney, (1) full-time Deputy Public Defender, (1) Probation Officer, (1) Law Enforcement Officer, (1) Coordinator, and (4) Representatives from community treatment providers, including Centers for Youth and Family Services, Professional Counseling Associates, Department of Human Services, and Veterans Affairs. Team members have attended training programs offered by the State of Arkansas Administrative Office of the Courts. Pulaski County Mental Health Court- Little Rock was implemented and operates according to the MHC Best Practices and Arkansas Law.
- d. **Sources of Funding:** Pulaski County Mental Health Court-Little Rock receives support from the City of Little Rock, the Public Defender Commission, the Pulaski County Prosecuting Attorney's Office, and Federal Providers.


- a. **Type of Program and Description of Operations:** The Alternative Sentencing Program (ASP) at NLRDC, Div. 1, is a form of probation that uses community resources to treat drug/alcohol addiction, to provide free educational services, and to provide cognitive behavioral therapy for those defendants who want to change their lifestyles; in exchange for consideration towards fines and jail time. Defendants are also assisted with job placement. The program is available to defendants who are in custody and is held during normal court sessions at North Little Rock District Court-1st Div. Criminal, 1 Justice Center Dr., North Little Rock, AR 72114.
- b. **Statutory/Legal Authority:** The Alternative Sentencing Program operates in compliance with A.C.A. § 5-4-303 Conditions of Suspension of Probation, A.C.A. § 5-4-322 District Court, Probation-Fees and Fines Authorized, & A.C.A. § 5-4-323 Additional Conditions- High School Diploma or High School Equivalency Diploma-Employment Training.
- c. **Certification of Compliance:** The judge utilizing this program certifies that the program conforms to all applicable sentencing laws, including assessments, collection and remittance of fines, court costs, and probation fees.
- d. **Sources of Funding :** The Alternative Sentencing Program operates at no additional cost to the Court. In addition, the program does not require a fee in order to participate. Community resources and non-profits are used to administer the program.





The Pulaski County Circuit Court has established a program offering substance abuse services and pre-trial release supervision to address the needs of high risk/high need persons who may suffer from, or are afflicted with, drug and alcohol addiction and related abuse disorders. Pursuant to Administrative Order No. 14 and Administrative Order No. 18, the administrative plan for the judicial circuit may refer to state district judges certain criminal duties with respect to an investigation or prosecution of an offense lying within the exclusive jurisdiction of the circuit court. The administrative plan for the 6th Judicial Circuit authorizes the state district judges in the 31st Judicial District to perform the following duties: Reasonable Cause Determinations pursuant to Rule 4.1 (e), Conduct First Appearances Pursuant to Rule 8.1, Appoint Counsel Pursuant to Rule 8.2, Inform Defendants Pursuant to Rule 8.3, Accept Pleas of “Not Guilty” or “Not Guilty by Reason of Mental Disease or Defect”, Conduct Pretrial Release Inquiries pursuant to Rules 9.1, 9.2 and 9.3, and Conduct Preliminary Hearings pursuant to A.C.A. §16-93-307. Accordingly, Judge Melanie Martin, Judge Randy Morley, and Judge Paula Juels Jones are designated to administer the Pulaski County Alternative Substance Abuse Services Program.

- f. **Type of Program and Description of Operations:** The Pulaski County Alternative Substance Abuse Services Program is a voluntary, pre-adjudication, highly intensive, pre-trial recognizance release supervision program designed to address the needs of high risk/high needs persons who may suffer from, or are afflicted with, drug and alcohol addiction and related abuse disorders. This pre-trial release program is available only to defendants meeting program eligibility requirements and is available to the departments of the district courts in the 31st Judicial District. The program is available to defendants who are in custody and during normal court sessions at Little Rock District Court-1st Div. Criminal, 600 W. Markham, Little Rock, AR 72201 & North Little Rock District Court-1st & 2nd Div. Criminal cases, 1 Justice Center Dr., North Little Rock, AR 72114.
- g. **Statutory/Legal Authority:** The Pulaski County Alternative Substance Abuse Services Program operates pursuant to Ark. R. Crim. P. Rules 8.1 through 9.6, Supreme Court Administrative Order No. 14, Supreme Court Administrative Order No. 18, other Arkansas Rules of Criminal Procedure, Arkansas state law, and the United States Constitution.

- h. **Certification of Compliance:** The judges utilizing this program certify that the program conforms to all applicable sentencing laws, including fines, fees, court costs, and supervision/probation assessments.
- i. **Sources of Funding:** This program is grant funded and requires no additional operating expenses for the Court(s). No financial commitments or additional human resources (which might result in any additional responsibilities by the Prosecuting Attorney or the Public Defender) will be requested or anticipated. When the grant expires, the Pulaski County Alternative Substance Abuse Program will cease, unless and/or until funded again, through the same or a similar grant.
- j. **Grant Name:** The name of the grant is the Pulaski County Substance Abuse Services Program. This program is established pursuant to a Pulaski County grant that assists qualifying defendants who are in custody to undergo drug and alcohol treatment at a designated contract facility.
- k. **Additional Resources:** The Pulaski County Alternative Substance Abuse Services Program receives support from the City of Little Rock, the City of North Little Rock, Pulaski County, the Public Defender Commission, and the Pulaski County Prosecuting Attorney's Office.

The Sherwood DWI Court is a specialty court that targets drunk drivers with a BAC of .17 or higher, who are “hardcore drunk drivers.” Most are charged with their second or third DWI. Upon a plea of guilty, they enter a one-year program of 4 phases, which includes extensive group and individual therapy, probationary supervision with alcohol testing, and court review every two weeks. The model is very similar to that used in Drug Courts. We meet every other Tuesday at 3:30 p.m. for staffing. Court begins after staffing at 4:00 p.m.

b) Provide the statutory and legal authority on which it is based:

A.C.A. §16-102-101 et seq. and Administrative Orders 14 and 18.

c) Certify that the program conforms to all applicable sentencing laws, including fines, court fees, and probation assessments.

I, Milas H. Hale III, do hereby certify that the program conforms to all applicable sentencing laws, including fines, court fees, and probation assessments.

d) Describe the program’s use of court resources, including without limitation, prosecuting attorneys or public defenders, and the availability of such resources and how they will be provided.

the costs associated with the treatment and probation since their fines are
suspended. Some Defendants are ADAP funded. We try to qualify them
upon entry of the program.

The program targets second and third DWI offenders, as well as first time offenders registering a BAC level of .15 or higher. The program, which began accepting referrals in August 2016, is available to all offenders identified as meeting program criteria. The program has been developed in line with and follows the Ten Guiding Principles as set out by the National Center for DWI Courts.

The program provides services, supervision and accountability that will assist the participants achieve and maintain his/her sobriety; thus reducing the number of impaired drivers in Pulaski County through a multi-disciplinary team. The Pulaski County District Court Sobriety/DWI Court is a post-adjudication sentencing alternative. Court is held every other Tuesday at 3:00 pm.

b) Provide the statutory and legal authority on which it is based:

A.C.A. § 16-102-101 et seq. and Administrative Order 18.

c) Certify that the program conforms to all applicable sentencing laws, including fines, court fees, and probation assessments.



Currently, there are no designated funds to support the Pulaski County District Court DWI/ Sobriety Court. Each county/state entity represented on the team, provides the representative considering the additional duties required by the team member to be inclusive of the respective duties of each. Donations are received from community organizations, churches and private individuals to be used for incentives, graduation gifts, food and bus passes. Pulaski County District Court purchases drug screens and other ancillary items from its own budget provided by the Pulaski County General Fund. Treatment for participants is funded by private insurance, Medicaid, state funds and private pay.

For training purposes, the District Court has applied for and received funds for \$15,000 from the Arkansas State Police Highway Safety Office. These funds allow team members to attend the Arkansas Drug Court Professionals Association and the National Association for Drug Court Professionals annual training conferences, which provides on-going training. A.C.A. § 16-10-139 now provides for fees and costs for specialty courts, which may be considered by our court in the future.




