Pursuant to Section 16A of the Procedures of the Arkansas Supreme Court Regulating Professional Conduct of Attorneys at Law (2003 Supp.) Panel B of the Committee on Professional Conduct was presented with proof of Mr. Clay's felony verdict and voted to place him on immediate interim suspension. The interim suspension became effective August 7, 2008.

Please be advised that a suspended attorney shall not be reinstated to the practice of law in this State until the Arkansas Supreme Court has received an affirmative vote by a majority of the Committee. If, and at such time as the Committee may reinstate the attorney, you will be provided notice of the reinstatement and the effective date thereof.

ORDER OF INTERIM SUSPENSION

Respondent Alvin D. Clay, Arkansas Bar ID #96075, an attorney practicing law primarily in Little Rock, Arkansas, was found guilty by a jury in the United States District Court for the Eastern District of Arkansas, in Case No. 04-CR-274, styled *USA v. Alvin Clay*, on June 4, 2008, of five felony criminal offense(s), being conspiracy to commit wire fraud (Count 1) and four Counts of engaging in a monetary transaction in property derived from wire fraud (Counts 2-5). Any felony is a "serious crime" as defined in Section 2.J of the Supreme Court Procedures Regulating Professional Conduct of Attorneys at Law (Rev. 2002) (the "Procedures").

Panel B of the Arkansas Supreme Court Committee on Professional Conduct (Committee), upon presentation of a file marked copy of the jury verdict forms found that Respondent had been adjudicated guilty of several felonies, and by a majority vote directed that Respondent's privilege to practice law in Arkansas should be suspended immediately under the provisions of Section 16(A)(2) and Section 17(E)(3)(b) of the Procedures, pending further disciplinary proceedings and action.

It is therefore ORDERED that the privilege of ALVIN D. CLAY, to practice law in the courts of the State of Arkansas be SUSPENDED on an interim basis immediately upon the filing of this Order with the Clerk of the Arkansas Supreme Court.
