- Administrative Order 8
- 10+ years old
- 2012: beginning of data quality project

Why change?

- Improve data quality
- Increase consistency
- Increase accuracy
- Processes have changed
- Greater public face
- More pro se litigants

Big Picture Changes

- Separate disposition information from filing
- Statistical Guide
 - New case types
- Consistent with Contexte

Purpose of cover sheets

- Clerks accurately record case information
- Provide judges and TCAs with basic case information
- Accurately identify individuals involved
- Anything else?

Disposition information

- Current form: bottom of cover sheet
- Change: separate form
- Purpose has changed
 - Past: for clerk to report to AOC
 - Future: for clerk to record outcome and case closure

- Cover sheet: person filing the case
- Disposition sheet: Who is the logical person?
 - Attorney drafting
