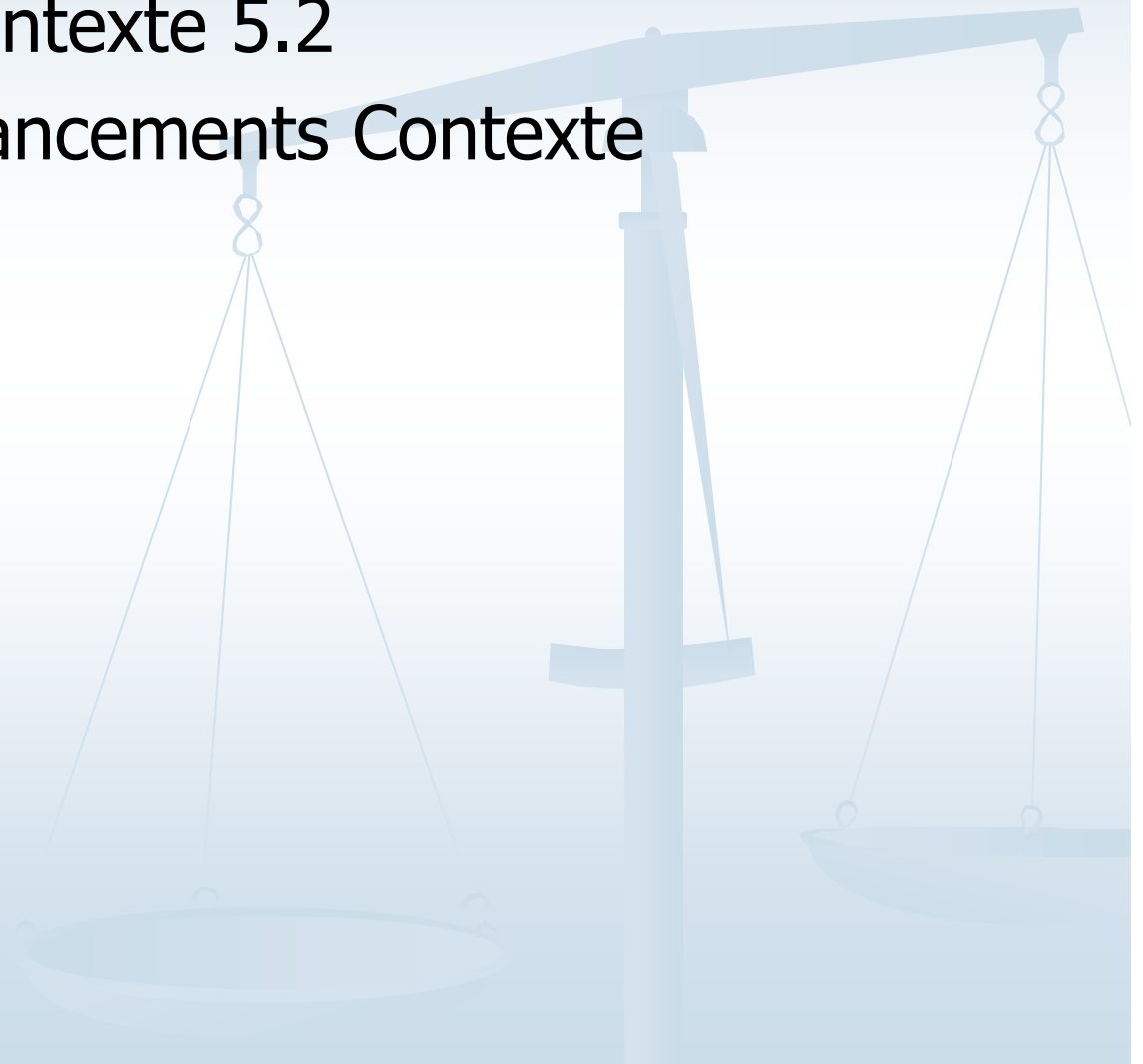

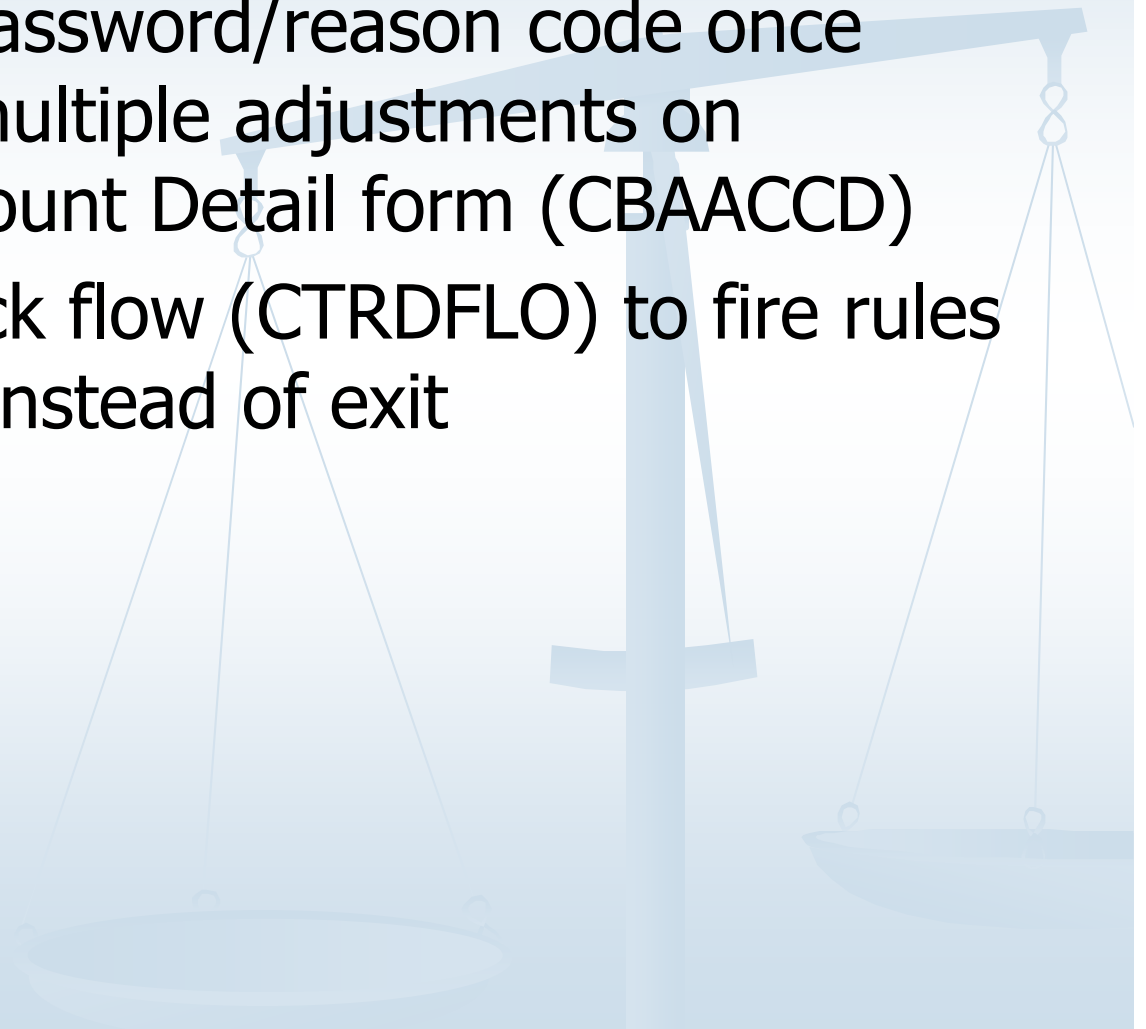
Contexte 7.1

- Currently Requirements Phase
- Projected Q4 2016 Delivery
- Focused on accounting RPE's

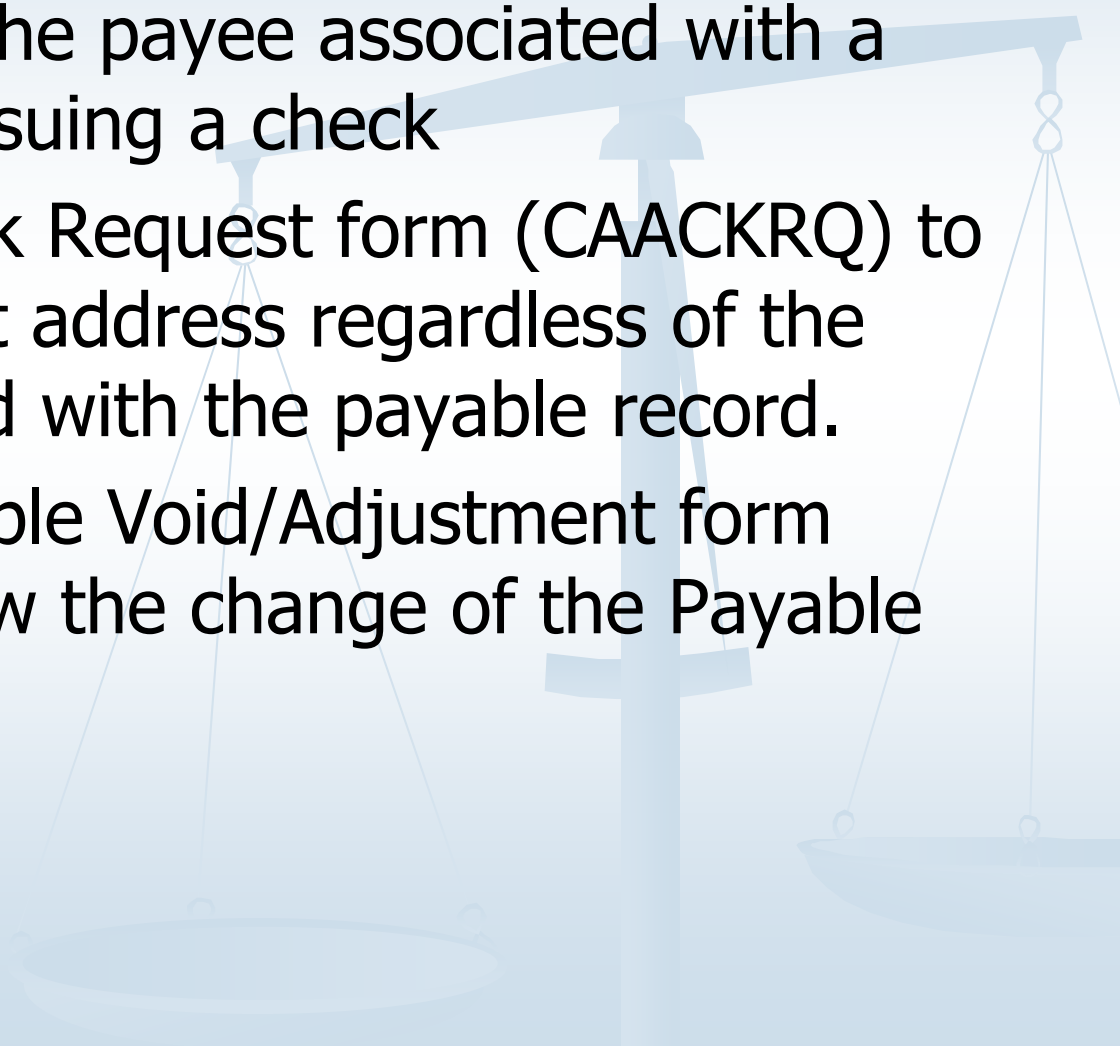


Contexte 7.1

- Ability to add password/reason code once when making multiple adjustments on Case/Party Account Detail form (CBAACCD)
- Update the quick flow (CTRDFLO) to fire rules based on save instead of exit



Contexte 7.1

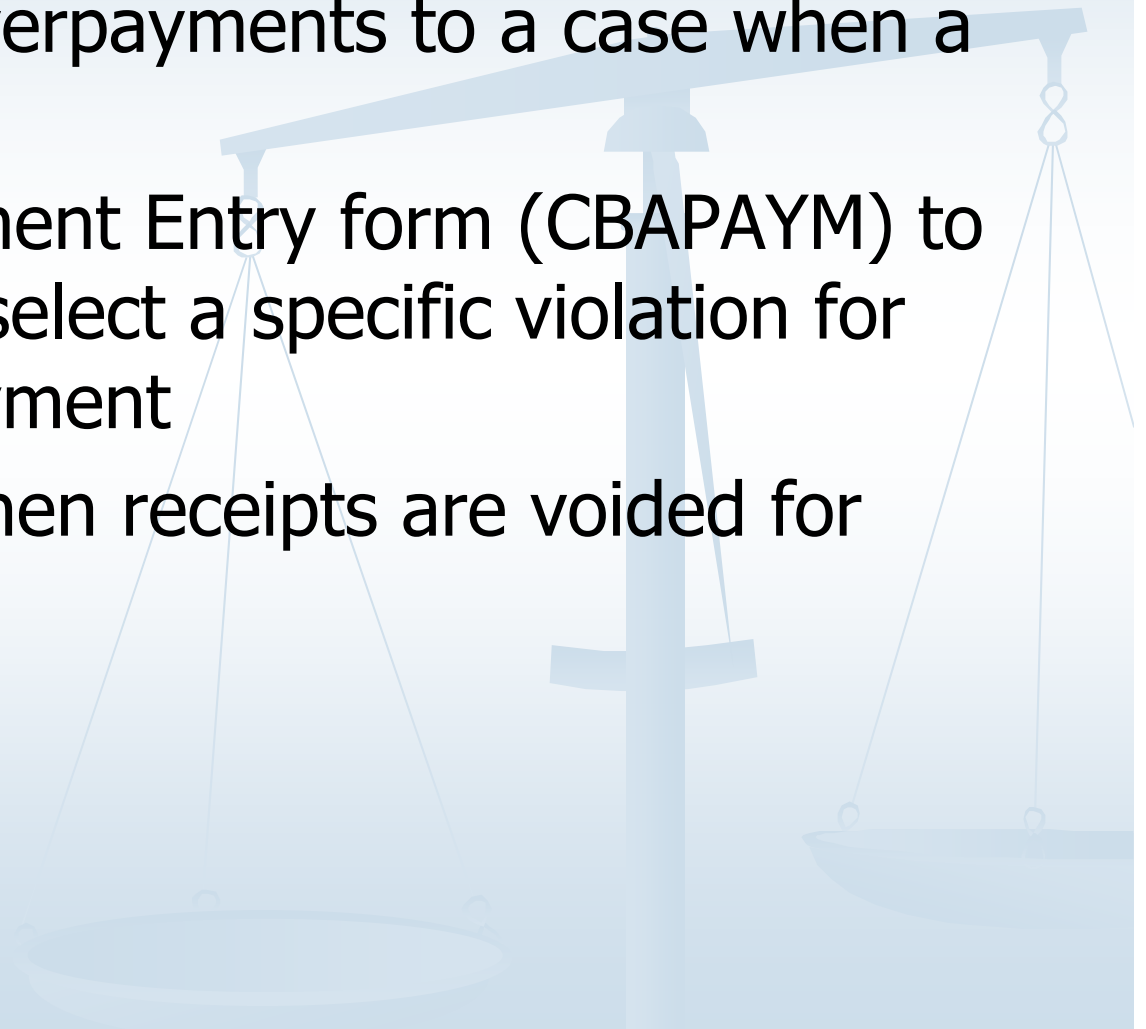
- Ability to change the payee associated with a payable prior to issuing a check
 - Updated the Check Request form (CAACKRQ) to look at the current address regardless of the address associated with the payable record.
 - Enhance the Payable Void/Adjustment form (CAAPADJ) to allow the change of the Payable Due Date
- 

Contexte 7.1

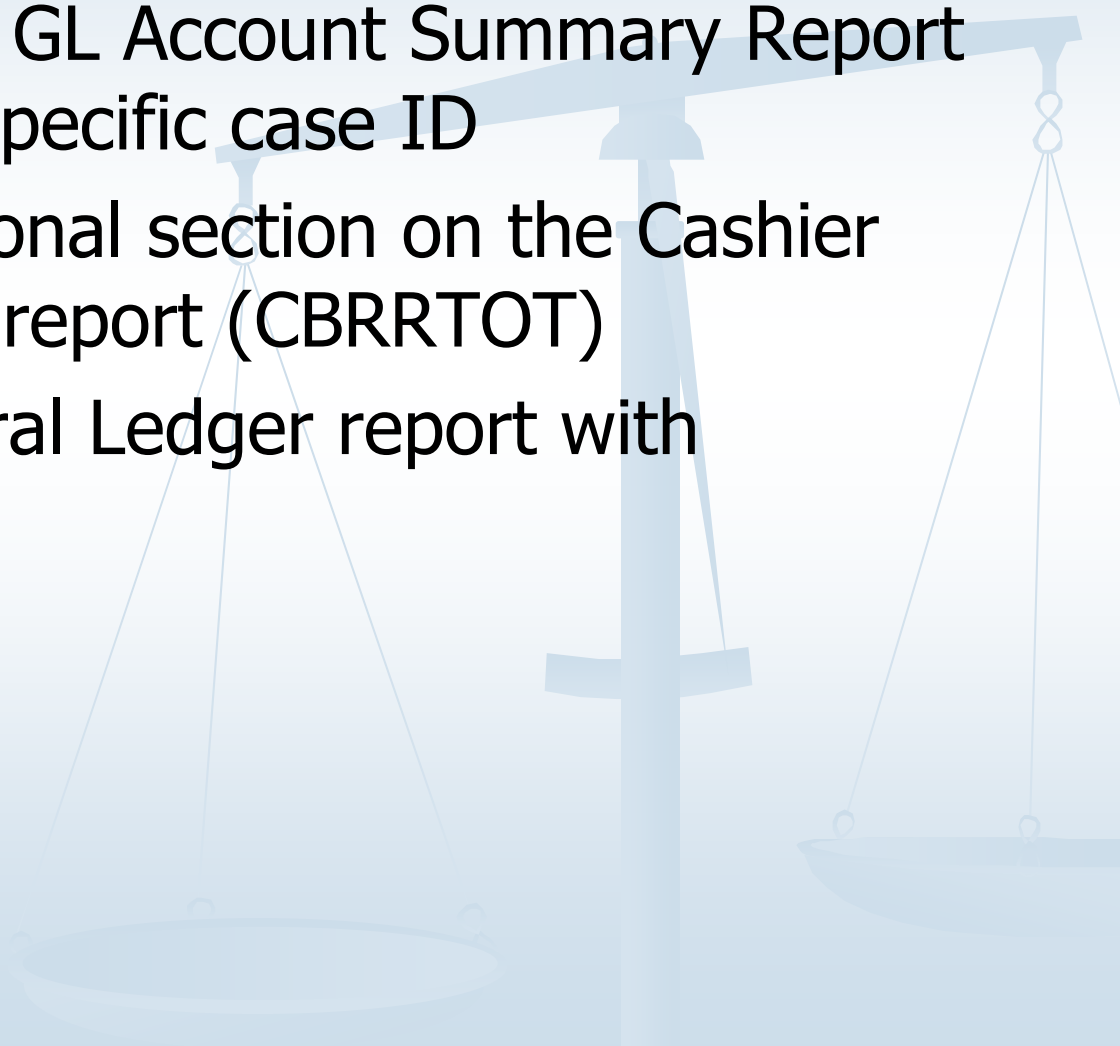
- Allow fees to be associated with either PLT or DFT on the Quick Case creation (CDAQCAS) form
- Create supervisor access to unlock check printer/correct starting check number
- Ability for a supervisor to reset GJAPRUN without involving the DBA

Contexte 7.1

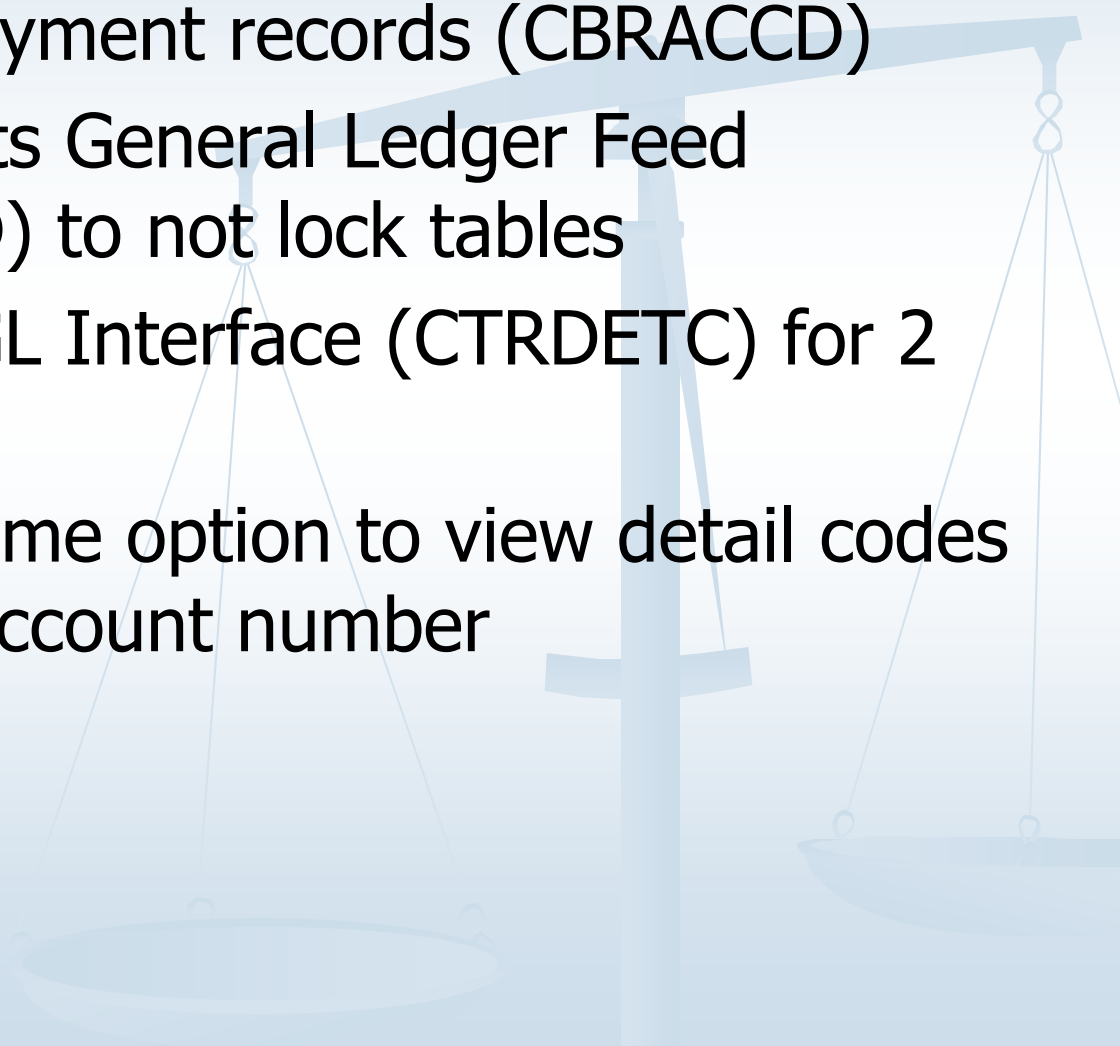
- Ability to relate overpayments to a case when a payable is created
- Enhance the Payment Entry form (CBAPAYM) to allow the user to select a specific violation for case/party for payment
- Apply a Docket when receipts are voided for bonds



Contexte 7.1

- Ability to print the GL Account Summary Report (CARCTGL) for a specific case ID
 - Enhance an additional section on the Cashier Session Summary report (CBRRTOT)
 - Add an new General Ledger report with Case/Party details
- 

Contexte 7.1

- Add Case ID to payment records (CBRACCD)
 - Enhance the Courts General Ledger Feed process (CAPCFED) to not lock tables
 - Ability to modify GL Interface (CTRDETC) for 2 credit accounts
 - Add navigation frame option to view detail codes associated to an account number
