Summary of Release:

The focus of this release is the creation of the Home dashboard to display reports about the cases and applicants for each user based on security settings. It is designed to allow users a quick glance of their program(s) and to make information generally requested in grant applications, such as demographics, readily accessible.

Additionally, enhancements were made to drug panel setup, drug test entry, and drug test results reports.

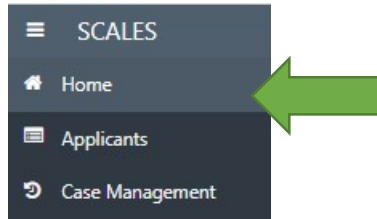
Finally, an issue where a name field pulled from the original case contained a comma and caused an error when trying to accept an application was fixed.

Details of Release:

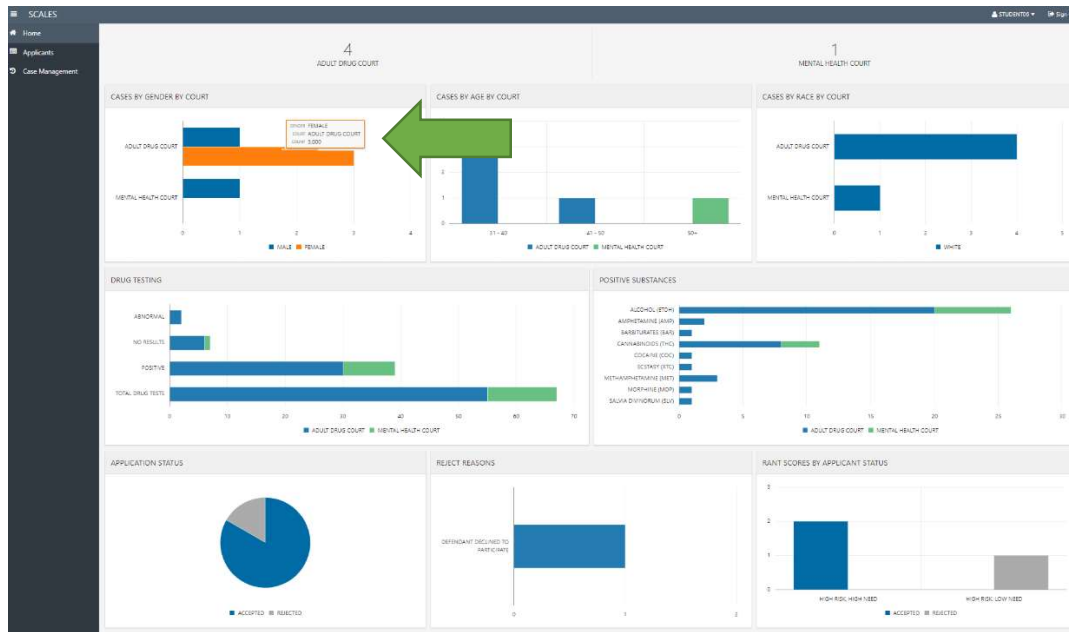
In this release **USERS** will be able to perform all functionality of the previous release plus the following:

1. **NEW** – View Home Dashboard

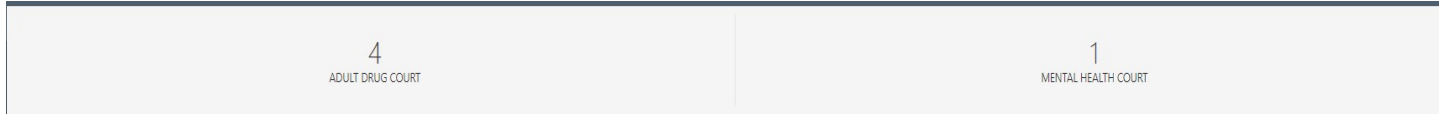
A new dashboard will now display when entering the application and can be accessed from the Home link on the Navigation Bar.



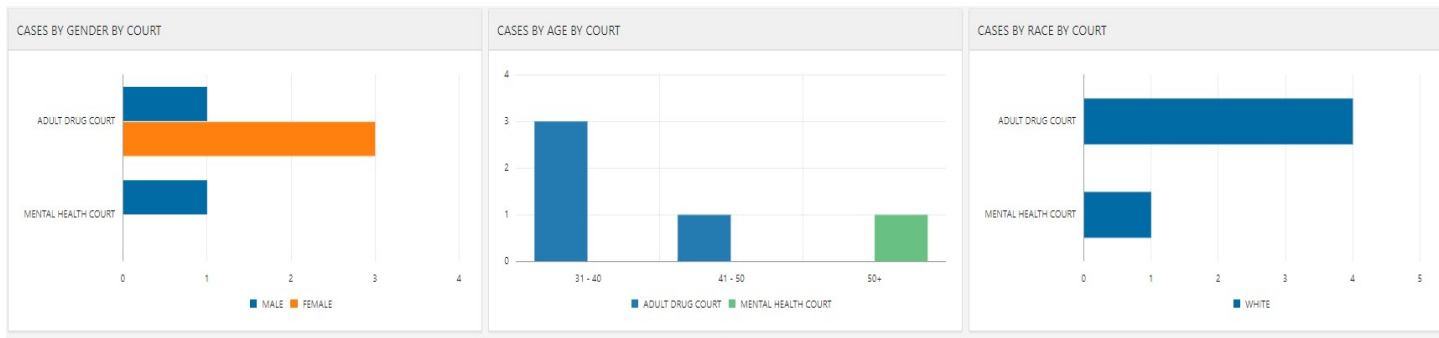
**NOTE:** User can hover over sections in the dashboard to quickly view results.



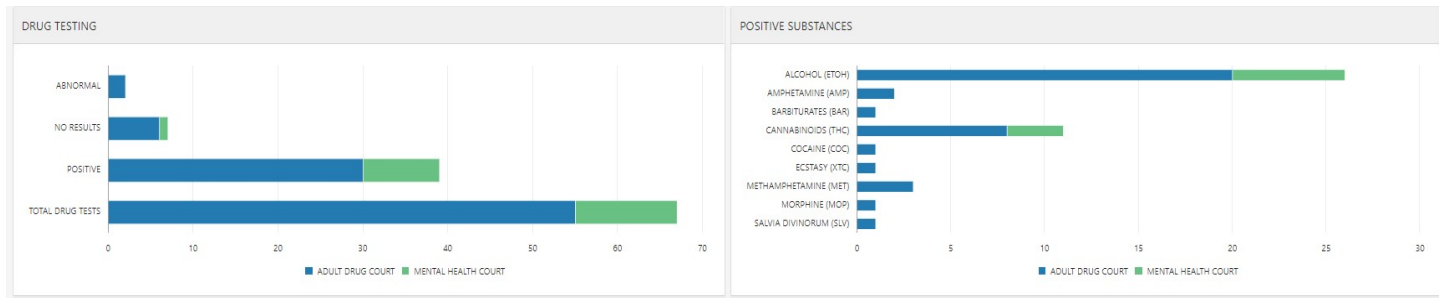
The top section displays the sum of **cases** based on user security in the Case Management dashboard by case type.



The next section displays demographic information (gender, age, and race) about **cases** by case type.



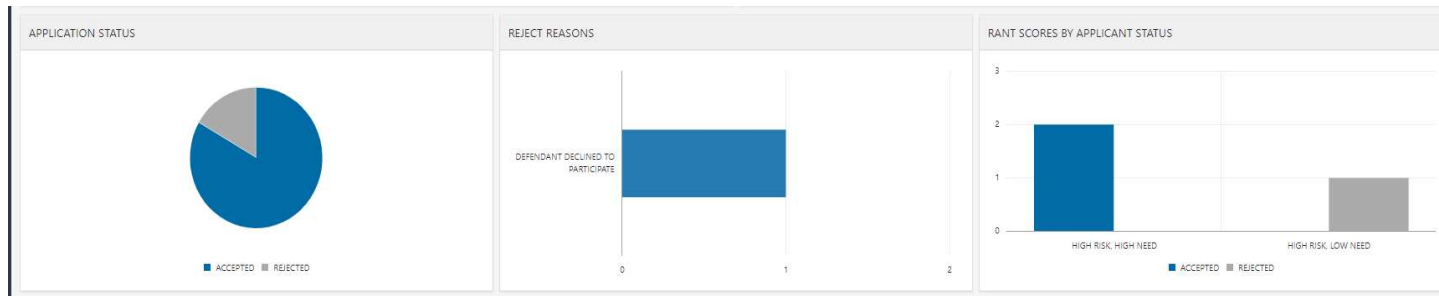
The third section displays information about **drug test results** by case type, specifically, drug testing results and positive substances.



General rules for counting result types in the DRUG TESTING report:

DRUG TESTING DASHBOARD	
NO RESULTS	# of entries where RESULT equals N/A, REFUSED TEST, or NO SHOW
ABNORMAL	# of entries where at least one RESULT = 'ABNORMAL'
POSITIVE	# of entries where at least one RESULT = 'POSITIVE' (NOTE: POSITIVE BUT WITH PRESCRIPTION is not counted here)
TOTAL TESTS	# entries regardless of RESULT

The last section displays information about **applications** such as status, reject reasons and RANT score by status.



2. **UPDATED** - Create and manage drug panel from the Application Settings (ADMINs only)
  - a. **CHANGE** - Substance list has been updated with current list from DEA and displays names with codes in parenthesis.
  
3. **UPDATED** - Enter drug test results from the Case Management dashboard
  - a. **CHANGE** - Substance list has been updated with current list from DEA and displays names with codes in parenthesis.
  - b. **CHANGE** - Added NO SHOW to RESULT TYPE options. Substances from panel selected will default to NO SHOW.
  - c. **CHANGE** - EXCUSED/MEDICAL to RESULT TYPE options. Substances from panel selected will default to EXCUSED/MEDICAL.
  - d. **CHANGE** - Added ABNORMAL to RESULT dropdown for substances to be selected for the newly added adulteration substances, CREATININE (CR), GENERAL OXIDANTS (OX), PH (PH), SPECIFIC GRAVITY (SG), NITRITE (N), AND GLUTARALDCHYDE (G).

  - a. **CHANGE** - Substance list has been updated with current list from DEA and displays names with codes in parenthesis.
  - b. **CHANGE** - Added NO SHOW to RESULT TYPE options. Substances from panel selected will default to NO SHOW.
  - c. **CHANGE** - EXCUSED/MEDICAL to RESULT TYPE options. Substances from panel selected will default to EXCUSED/MEDICAL.
  - d. **CHANGE** - Added ABNORMAL to RESULT dropdown for substances to be selected for the newly added adulteration substances, CREATININE (CR), GENERAL OXIDANTS (OX), PH (PH), SPECIFIC GRAVITY (SG), NITRITE (N), AND GLUTARALDHYDE (G).

- 5. **FIXED** – applications with commas in a name field pulled from the original case information can now be accepted without error.
