
I hope that you find this catalog helpful, and that you are able to attend one of these engaging educational programs.

CERTIFICATION

Mediators eligible to mediate cases from the Arkansas Circuit Courts for compensation must be certified by the Arkansas ADR Commission. The Commission has established standards for mediator certification, professional conduct and discipline with which applicants must comply in order to be included on the Roster of Certified Mediators. The Roster is provided to every circuit court judge in the state, posted to our website and made available to anyone who contacts our office seeking a mediator.

There are four categories of certification: civil, probate, domestic relations and juvenile. The education, training and practical experience requirements vary for each of the categories, and the specifics are set out in the *Requirements* for the Certification of Mediators for Circuit Courts.

Certified mediators are required to adhere to ethical standards and are subject to a disciplinary process. The Commission has no authority over mediators who are not certified.

CONTINUING MEDIATION EDUCATION

In order to maintain good standing, certified mediators must complete six hours of continuing mediation education (CME) each reporting period. The reporting period begins on September 1 and ends on August 31. On even years, the Commission hosts a statewide ADR conference. On odd years, the Commission offers a series of CME programs throughout the year. The programs may be webinars or in-person events.

Duplicate attendance of regionals is not available for CME credit.

Additionally, programs conducted by other organizations and individuals may be approved by the Commission for CME credit. The application for CME course approval can be found on the Commission's website at:

Deirdre McCarthy Gallagher is a mediator, facilitator and trainer with JAMS, the world's largest private ADR provider, and the associate director of the JAMS Institute, Before coming to JAMS in

She has move than 24 years of experience as a conflict resolution trainer and practitioner. She has mediated two-party and multi-party disputes in a variety of areas, including employment, business, nonprofit, governmental/public policy, education. environmental and energy. She is experienced at facilitating organizational dialogues with higher education institutions, associations and government agencies and has served as the co-facilitator of a federal advisory committee. McCarthy Gallagher has a particular interest in understanding dispute systems, believing that this is critical to managing conflict productively. She has conducted conflict assessments and created training and capacity-building programs for both the public and private

McCarthy Gallagher received her AB from Harvard University, her MS from the School for Conflict Analysis and Resolution at George Mason University, and her JD from Georgetown University Law Center. She is an adjunct professor of negotiation and mediation at Georgetown and the co-author of Alternative Dispute Resolution in the Regulatory Process, published by Michigan State University Press. She is also the chair of the American Bar Association Section of Dispute Resolution's Committee for Committee Development and Oversight and a volunteer with the Divided Communities Project.

is an adjunct professor at Lipscomb University's Institute for Conflict Management, and she taught at Pepperdine University School of Law's Straus Institute for Dispute Resolution from 1988 until 2015. In September 2021, she taught the Arkansas Family Mediation Training. Cynthia has a master's degree in dispute resolution from Pepperdine School of Law, a doctorate in organizational management from Pepperdine University and a masters in counseling and psychology from Georgia State University. She has mediated since 1994 and has conducted more than 1,350 mediations. She has developed ADR systems for various non-profit, governmental and nongovernmental organizations, and she is a mediator and trainer for the U.S. Postal Service REDRESS program. For 10 years, she was the director and senior mediator at the California Academy of Mediation Professionals in Encino, Calif. Prior to that, for 17 years, she was an assistant and associate dean at Pepperdine University School of Law. In addition to her extensive practice experience, she has trained mediators across the nation. In Tennessee, she is listed as a Rule 31 Mediator for civil, family and domestic violence cases. At Lipscomb, she teaches the Rule 31 Family Mediation (Divorce) Training and the Rule 31 Domestic Violence Training. She also teaches ADR in Educational Settings, Interviewing and Counseling in ADR, and ADR in Organizations. For Atlanta's John Marshall Law School, she teaches Interviewing, Counseling and Planning for Lawyers, and for the LL.M. program there, she teaches ADR in Employment Settings.



40-HOUR CIVIL TRIAL COURT MEDIATION TRAINING

The focus of this training is mediating the litigated civil case. Participants will be introduced to mediation as an alternative way to resolve conflicts. Participants are taught skills used in the mediation process through lecture, discussion and role play. The goal of this course is to assist participants in gaining the skills needed to be an effective mediator.

This course satisfies the 40-hour basic or civil mediation training set forth in the *Requirements for the Certification of Mediators for Circuit Courts*. However, participants who complete this course are not automatically certified by the Arkansas ADR Commission. Certification can only be achieved by successfully completing the certification application process, which includes meeting additional education, practical experience and ethical standards.

The Arkansas Alternative Dispute Resolution Commission was created by Act 673 of 1995 and consists of seven volunteer members who have demonstrated prior interest or involvement in alternative dispute resolution. Members are appointed by the Chief Justice of the Supreme Court of Arkansas, Governor, President Pro Tempore of the Senate and Speaker of the House of Representatives.

The primary mission of the Commission is to encourage, promote and develop the voluntary use of alternative dispute resolution processes to resolve disputes, cases and controversies of all kinds.

The Administrative Offices of the Courts (AOC) provides general staff support, facilities and operating assistance for the Commission. The AOC is an agency within the judicial branch of government that works to support the state courts on behalf of the Arkansas Supreme Court.

The mission of the Administrative Offices of the Courts is to support the Arkansas Judiciary and employees of the judicial branch and to assist attorneys and members of the public who rely upon an independent state court system that is efficient, accessible and fair to all.
