1. **JUDGE:** The Third Judicial District Court is served by one state district judge, who is Dale Ramsey.

In addition, the Court conducts first appearances (8.1 hearings) for all inmates who are scheduled for such a hearing in Carroll County every Monday, Wednesday, and Friday (unless that day falls on a holiday) at approximately 2:00 in the afternoon at the Berryville Detention Center.

3. **TYPES OF CASES:** The following cases are heard at these locations:

Berryville Department (City & Eastern District Carroll County) – Traffic, Misdemeanor, Civil and Small Claims

Eureka Springs Department (City & Western District Carroll County) – Traffic, Misdemeanor, Civil and Small Claims

Green Forest Department (City only) – Traffic and Misdemeanor

Huntsville Department (City & Madison County) – Traffic, Misdemeanor, Civil and Small Claims

4. **SPECIALTY PROGRAMS:** No specialty programs are provided.
