Offenses that require a \$100 fine under Ark. Code Ann. § 5-4-703:

- A "felony involving violence" under Ark. Code Ann. § 5-4-501(d)(2):
 - Murder in the first degree
 - Murder in the second degree
 - Kidnapping
 - Aggravated robbery
 - o Rape
 - Battery in the first degree
 - Sexual assault in the first degree
 - Sexual assault in the second degree
 - Domestic battering in the first degree
 - Residential burglary
 - o Aggravated residential burglary
 - Unlawful discharge of a firearm from a vehicle
 - Criminal use of prohibited weapons (if Class B felony)
 - Aggravated assault upon a law enforcement officer or an employee of a correctional facility (if Class Y felony)
 - Felony attempt, solicitation, or conspiracy to commit:
 - Capital murder
 - Murder in the first degree
 - Murder in the second degree
 - Kidnapping
 - Aggravated robbery
 - Aggravated assault on a law enforcement officer or correctional employee (if Class Y felony)
 - Rape
 - Battery in the first degree
 - Domestic battering in the first degree
 - Residential burglary
 - Aggravated residential burglary
- Manslaughter or negligent homicide
- False imprisonment in the first or second degree
- Battery in the second or third degree
- Aggravated assault in the first, second, or third degree
- Coercion
- Introduction of a controlled substance into the body of another person
- Terroristic threats or acts
- Sexual indecency with a child
- Indecent exposure
- Sexual assault in the third or fourth degree
- Trafficking persons or patronizing a human trafficking victim
- Domestic battering in the second or third degree

Quick Reference Sheet for Children's Advocacy Center Fund

- Aggravated assault on a family or household member
- Assault on a family or household member in the second or third degree
- Endangering the welfare of a minor in the first, second, or third degree
- Engaging in sexually explicit conduct with a child for use in visual or print media
- Pandering in (i.e. selling, distributing, or receiving) or possessing visual or print media depicting sexually explicit conduct involving a child
- Transporting minors for prohibited sexual conduct
- Internet stalking of a child
- Sexual grooming of a child
- Employing or consenting to the use of a child in a sexual performance
- Producing, directing, or promoting a sexual performance by a child
- Distributing, possessing, or viewing matter depicting sexually explicit conduct involving a child
- Computer child pornography
- Failure to report child pornography
- Computer exploitation of a child
- Fleeing by means of a vehicle or conveyance
- Aggravated cruelty to a dog, cat, or equine
- A controlled substance offense in which an enhanced penalty is applied under Ark. Code Ann. § 5-64-406 (delivery to minors) or § 5-64-407 (manufacture of methamphetamines in the presence of certain persons)
- Driving or boating while intoxicated
- Reckless driving

Offenses that require a \$5 fine under Ark. Code Ann. § 27-50-306:

- Speeding in excess of twenty miles per hour over the speed limit with a minor passenger in the vehicle
- Reckless driving (unless addressed under Ark. Code Ann. § 5-4-703)
