





Codes that will Trigger Case Status

- OPEN-case status
 - ➤ MFO MOF ORIGINAL
 - ➤ MFT MOF TRANSFER
- CLOSED-case status
 - ➤ JUCO CASE CLOSED
 - > MDCO CONSOLIDATED
 - MDTR MOD TRANSFER TO OTHER JURISDICTION
 - ➤ MDJD MOD JUDGMENT/DECREE/ORDER
 - ➤ MDDM MOD DISMISSED

Codes that will Trigger Case Status

- INACTIVE-case status
 - ➤ MSIA MOD INACTIVE
 - MDRB MOD REMOVED TO BANKRUPTCY
 - MDRF MOD REMOVED TO FEDERAL
 - MDAR-MOD ARBITRATION
- REACTIVATE-case status
 - ▶ MFF MANNER OF FILING REACTIVATED
- REOPEN-case status
 - ➤ MFR + CASE TYPE; when used will update case status
- MONITORING-case status
 - ➤ NO RULE Must be manually applied on CDACSTS
