# WHY A NEW SENTENCING ORDER FORM?

#2017ACAP

- Another step down the road towards “paperless”
- Increasing data quality by decreasing manual entry
- Data Exchange with Arkansas Department of Corrections and Arkansas Community Correction

Contexte data to ADC / ACC	Demographics, Sentencing Orders, Warrants, Events, etc.
ADC / ACC data to Contexte	Demographics, Offender Photo, Offender Status and Location, Parole Board Warrants, etc.
