1. **JUDGE:** The Cross County District Court is served by one local district judge, Judge Mike Smith. The judge serves in the designated departments of the court as follows;

2. **COURT:** Sessions of court are generally scheduled on:

The court makes itself available to local law enforcement to conduct hearings required under Arkansas Criminal Procedure Rule 8 in a timely manner as required.

3. TYPES OF CASES:

Traffic and criminal offenses filed thru the Cross County Sheriff's Department, the City of Wynne Police Department, the Arkansas State Police, and the Arkansas Game and Fish Commission are adjudicated in the Cross County District Courtroom in Wynne, AR.

Traffic and criminal offenses filed thru the Cherry Valley Police Department are adjudicated in the Cross County District Courtroom in Wynne, AR.

Traffic and criminal offenses filed thru the Parkin Police Department are adjudicated in the Cross County District Courtroom located at the Parkin City Hall in Parkin, AR.

Civil/Small claims cases are adjudicated in the Cross County District Courtroom in Wynne, AR.


4. JURISDICTION EXCHANGE AGREEMENTS:

The court enters and maintains exchange agreements with the Honorable Ron Hunter of the Poinsett County District Court for exchanges of jurisdiction for arraignments and trials where there may possibly be a conflict of interest. Exchanges are scheduled on an as needed basis.

5. SPECIALTY PROGRAMS:

The Cross County District Court does not operate or administer any specialty programs.
