

ADMINISTRATIVE PLAN

9th Judicial District District Court of Faulkner County, Arkansas and District Court of Van Buren County, Arkansas

1. JUDGES.

The Faulkner County District Court and the Van Buren County District Court are state district courts served by two (2) judges. Judge David Reynolds was elected to the judgeship statutorily designated as Division 1, and Judge Chris Carnahan was appointed to the judgeship statutorily designated as Division 2. The statutorily designated departments of the 9th District include Conway, Greenbrier, Guy, Mayflower, Vilonia, Clinton and Damascus.

The assignment of judges to department is determined by mutual agreement of the state district judges in the 9th District.

ADMINISTRATIVE POLICY

The judges shall meet periodically (no less than quarterly) and shall consider case management, administrative procedures, forms, calendars, etc. Any modification of this plan shall be by written agreement signed by both judges of the district. Each year a calendar shall be printed and published indicating such courtroom assignments and court dates.

CASE ASSIGNMENT AND ALLOCATION

The clerk of each department shall assign newly filed cases by computer program as provided in the attached Case Allocation.

ARRAIGNMENTS, EMERGENCY, AND UNCONTESTED HEARINGS

It is preferable for the division assigned to a case to handle all proceedings concerning the case. However, both judges may preside over arraignments, probations revocation and uncontested matters when presented and may sit on exchange when necessary. Emergency orders shall be presented to and heard by the judge assigned unless that judge is unavailable. In no event shall any Judge refuse to act on any case not part of their assignment for lack of jurisdiction.

The following specialty courts are conducted: Sobriety Court programs are offered to qualifying Second and Third Offense Driving While Intoxicated defendants in Faulkner and Van Buren counties.

a. Type of specialty docket and description of its operation:

DWI Court / Sobriety Court

The Sobriety Court programs is offered to qualifying defendants charged with Second and Third Offense Driving While Intoxicated in Faulkner and Van Buren Counties.

Special dockets have been created as subdivisions of the criminal dockets in both Faulkner and Van Buren called Sobriety Court. While Sobriety Court is purposed to serve second and third violators of Ark. Code Ann. 5-65-103, there may be admissions for certain persons with excessively high blood alcohol results at the time of arrest and a therapeutic need to get specialized treatment that this program

offers. These specialty dockets are staffed by the treatment team before the Public Docket is called later the same afternoon.

Staffings are now HIPPA compliant as participants personal medical and psychiatric information is shared and discussed with the program team. Our Sobriety Court approach to treatment and healing is a collaborative approach with various specialist, providers, and law enforcement resources sharing during and outside of staffing to better individualize recovery outcomes.

The Faulkner County Sobriety Court meets every other Friday at 1:30 p.m. for staffing with the public docket usually called at 2:30 p.m., unless there is a matter or matters that take a little more time. The Public Docket portion of our Sobriety Court is open to the general public and we discuss positive and negative aspects of each attendee's recovery. Encouragement and sanctions in various forms are dispensed by the Judge. Group therapy sessions for all participants follow the Public Docket at Conway Counselling.

The Van Buren County Sobriety Court meets every other Thursday at 3:00 p.m. for staffing with the Public Docket taking place immediately following. Group session are on Wednesdays. This Court mirrors the operation of the Faulkner County Sobriety Court. The meeting of these courts on separate weeks is to accommodate the circuit of courts the Division II judge travels to.

As this is a program modeled after the National Drug Court Institute's and the Arkansas Drug Court Best Practice Standards, Sobriety Court promotes through four phases of treatment. Phase One is the most intensive therapeutic and supervised portion of our program with mandatory real time alcohol testing and frequent random drug tests, and more interactions with psychological counseling. The Fourth Phase of the program has greatly reduced direct supervision of the participant: the focus is preparing the participant to soon reenter life sober and chem free. In addition to individualized and group sessions, participants are encouraged to add marriage/relationship counselling when appropriate, although this is not ordered by the Court.

As of August 1, 2019, each incoming participant without a regulated trade or college degree will undergo testing with the University of Arkansas Morrilton, Career Education to determine if there are any needs to achieve a high school equivalency or alternatively a national certification with a career readiness certificate. This may take up to 50 additional hours over the first two phases of the program to complete. Beginning January 1, 2020, incoming participants will complete a personal budgeting course taught by a registered financial counsellor. This course of study will take place over five weekly sessions. Sobriety Court also participates in the Arkansas Highway Department's Adopt-a-Highway Program.

Upon successful completion of the program, participants receive a graduation certificate and a graduation party. Family members and friends of the graduate are encouraged to attend.

b. Statutory or legal authority on which it is based:

Arkansas Supreme Court Administrative Orders 14 and 18, A.C.A. § 5-65-103 et. seq. and / or A.C.A. § 16-98-303 et. seq. and ACT 1044 of 2019.

c. Certification of compliance with all applicable sentencing laws, including assessment, collection and remittance of fines, fees, court costs, probation fees.

We hereby certify that the Faulkner and Van Buren County Sobriety Courts operate in compliance with all applicable laws, including fines, court costs, participant fees, probation assessments and jail punishment.

d. Use of court resources.

The Faulkner and Van Buren County Sobriety Court Teams include Judge Chris Carnahan, the Sobriety Court coordinator, who is the Division II head clerk, a deputy prosecutor, a deputy city attorney for the City of Conway in Faulkner County and the City Attorney for the City of Clinton in Van Buren County, a public defender, probation officer/case manager, evaluator(s), treatment provider(s), monitoring service technicians, bailiffs, and a court liaison/law enforcement member (this position is currently vacant in Faulkner County but discussions are underway to replace this position). Team members have attended training programs offered by the National Center for DWI Courts (NCDC) in collaboration with the National Association of Drug Court Professionals (NADCP) and the National Highway Traffic Safety Administration (NHTSA).

Both Sobriety Courts have implemented and operates according to the NCDC's Ten Guiding Principles and Arkansas law. Judge Carnahan recently was certified by the National Judicial College for completing its week-long Impaired Driving course. Sobriety Court takes place in the Faulkner County District Court building and in the Van Buren County Courthouse.

e. Sources of funding:

The Sobriety Courts are funded by grants from the Arkansas State Police Highway Safety Office in conjunction with NHTSA, participant fees, community donations and other applicable grants. The NJC's Impaired Driving course was provided through a grant.

This specialty court was established in the circuit court administrative plan, but the judicial circuit does not have a circuit judge who is available to administer the specialty

court on a consistent basis. Accordingly, the administrative plan for the judicial circuit required by Administrative Order No. 14 of the Supreme Court designated a district court judge to administer this specialty court program.

Domestic Violence Docket

Judge Reynolds hears all misdemeanor domestic violence cases from the criminal docket in the Clinton, Conway, Greenbrier, Guy and Mayflower departments. There is not currently a domestic violence docket in the Damascus and Vilonia departments.

b. Statutory or legal authority on which it is based:

Supreme Court Administrative Order 18 and requires district court judges to establish subject-matter divisions in each district court for criminal, civil, traffic and small claims. The creation of the Domestic Violence Docket within the criminal division serves the purpose of judicial administration and caseload management in addition to better judicial outcomes for both victims and defendants.

c. Certification of compliance with all applicable sentencing laws, including assessment, collection and remittance of fines, fees, court costs, probation fees.

We hereby certify that the Faulkner and Van Buren County Sobriety Courts operate in compliance with all applicable laws, including fines, court costs, participant fees, probation assessments and jail punishment.

d. Use of court resources.

No additional resources are required.

e. Sources of funding:

The Domestic Violence Docket is part of the required criminal division and is funded by the district court's operational expense budget. No additional source of funding is required.
