

**29<sup>TH</sup> DISTRICT COURT**  
**ADMINISTRATIVE PLAN**  
(Jefferson and Lincoln Counties)

Pursuant to Arkansas Supreme Court Administrative Order 18, the Judges of the 29<sup>th</sup> District Court District submit this Administrative Plan.

1. Divisions. The 29<sup>th</sup> District Court District comprises Jefferson and Lincoln Counties. The District is served by three State District Judges:

Division 1	Kimberly C. Bridgforth
Division 2	John L. Kearney
Division 3	Phillip C. Green

2. Departments. The District contains nine (9) departments. Those departments and the divisions to which they are assigned are:

Pine Bluff	Division 1 (County dockets) Division 2 (City dockets)
Altheimer	Division 1
Humphrey	Division 1
White Hall	Division 1
Wabbaseka	Division 1
Redfield	Division 1
Star City	Division 3
Grady	Division 3
Gould	Division 3

3. Court Sessions. Court is generally scheduled as follows:

Pine Bluff	Monday through Friday (city and county dockets)
Altheimer	Fourth Wednesday each month
Humphrey	Second Tuesday every other month
Redfield	Second Wednesday each month
Wabbaseka	Second Tuesday each month
White Hall	First and Third Wednesday each month
Star City	First Tuesday and Third Thursday (county dockets), First Tuesday, Third Tuesday, and Fourth Wednesday (city dockets)
Grady	First and Third Wednesdays
Gould	Second and Fourth Tuesdays

4. Types of Cases. The following cases are heard at these departments:

Pine Bluff	Traffic, Criminal, Civil and Small Claims, Felony First Appearances and Probable Cause Hearings
Alzheimer	Traffic and Criminal Cases occurring within the city limits
Humphrey	Traffic and Criminal Cases occurring within the city limits
Redfield	Traffic and Criminal Cases occurring within the city limits
Wabaseka	Traffic and Criminal Cases occurring within the city limits
White Hall	Traffic and Criminal Cases occurring within the city limits
Star City	Traffic, Criminal, Civil and Small Claims, Felony First Appearances and Probable Cause Hearings
Grady	Traffic and Criminal Cases occurring within the city limits
Gould	Traffic and Criminal Cases occurring within the city limits

5. Specialty Programs. The following specialty programs are provided:

DWI Court: This Court is held at the Pine Bluff Department, County docket, Division 1. The Court meets with multiple DWI offenders each Tuesday. Participants are tested, and any personal or compliance issues are addressed. The team members are: Judge, Court personnel, Prosecuting Attorney, Public Defender, treatment professionals, and law enforcement representatives. The Court is funded by a court budget, personal donations, and the Court's Administration of Justice fund.


Veteran's Court: This Court is held at the Pine Bluff Department, County docket, Division 1. It meets the second Thursday of each month and is funded by the Veteran's Administration.
