DISTRICT COURT ADMINISTRATIVE PLAN


Pursuant to Administrative Order No. 18 of the Arkansas Supreme Court, the undersigned District Judge proposes this Administrative Plan for submission to the Supreme Court.

- 1. JUDGES: The Hoxie, Walnut Ridge, and Black Rock departments of the Lawrence County District Court are served by one District Judge, Adam Weeks.
- 2. COURT: Sessions of the courts are generally scheduled as follows:

- 3. TYPES OF CASES: The Hoxie, Walnut Ridge, and Black Rock departments hear City and County misdemeanor criminal cases, traffic offenses, Game and Fish violations, State Police and Highway Department cases. They also maintain a Civil and Small Claims docket and conduct felony preliminary hearings and issue Arrest and Search Warrants.
- 4. SPECIALTY PROGRAMS: The Lawrence County District Court currently has no specifically designated specialty programs.
- 5. Portia Arkansas previously had a District Court. That court has gone dormant. Portia has no Police Department. It has been years since it has been active. I'm unaware of any ordinance passed by the city abolishing its court.
