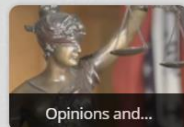

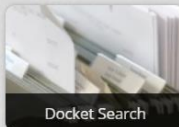



In 1836, Arkansas became the 25th state admitted to the union. Its first constitution created a supreme court composed of three judges including one styled Chief Justice, and directed that the judges be elected by the Arkansas General Assembly. *Ark. Const. of 1836*, art. VI, § 52 & 7. Daniel Ringo, Townsend Dickinson, and Thomas J. Lacy were selected to serve as the first supreme court judges, and Mr. Ringo became the first Chief Justice.

The state's current constitution, ratified in 1874, likewise initially provided for three supreme court judges, but also authorized the Arkansas General Assembly to increase the number of judges to five, if it deemed necessary, when the state population amounted to one million. *Ark. Const. of 1874*, art. VII, § 52 & 3. By Act 10 of 1880, the number of supreme court judges increased to
