



EXECUTIVE ORDER

- WHEREAS,** the Center for Disease Control and Prevention (CDC) is responding to an outbreak of respiratory disease caused by a novel (new) coronavirus that was first detected in China and which has now become a world-wide pandemic. The virus has been names "SARS-CoV-2" and the disease it causes has been named "coronavirus disease 2019" (abbreviated "COVID-19"); and
- WHEREAS,** COVID-19 is a severe acute respiratory illness that can spread among humans through respiratory transmission and presents with symptoms which may not immediately be known to an individual who is positive for COVID-19; and
- WHEREAS,** The World Health Organization declared COVID-19 a Public Health Emergency, and a new and significant outbreak has emerged internationally as well as in the United States; and
- WHEREAS,** The CDC has deemed it necessary to restrict or prohibit certain non-essential travel. The CDC currently recommends community preparedness and everyday prevention measures be taken by all individuals and families in the United States, including voluntary home isolation when individuals are sick with respiratory symptoms, covering coughs and sneezes with a tissue and disposal of the tissue immediately thereafter, washing hands often with soap and water for at least 20 seconds, use of alcohol-based sanitizers in the event that soap and water are not immediately available and routinely cleaning frequently touched surfaces and objects; and
- WHEREAS,** numerous individuals have tested positive for COVID-19 and found to be present in more that fifty (50) Counties in the State of Arkansas, with some of those cases resulting in death; and
- WHEREAS,** the CDC, Federal Government and State Government have recommended mitigation measures, including staying home when sick, keeping away from others who are sick and staying at home when a household member is sick with respiratory disease symptoms or if instructed by health care officials; and
- WHEREAS,** the Governor of Arkansas has directed that individuals do not gather in groups larger than ten (10) in number and has signed and requested a Major Disaster

Declaration for the State of Arkansas as a result of COVID-19, which has been submitted to President Trump; and

WHEREAS, President Trump has invoked Federal Emergency Powers related to COVID-19 and made Major Disaster Declarations for multiple States regarding COVID-19; and

WHEREAS, Multiple States, Counties, and or Municipalities have invoked “shelter in place” or other similar quarantine measures restricting travel due to COVID-19; and

WHEREAS, the State of Arkansas has advised that individuals who have COVID-19 should remain isolated between seven (7) to fourteen (14) days once symptoms of the virus have resolved; and

WHEREAS, Miller County must ensure, as best as can reasonably be accomplished, the health and safety of County Employees and the public served by Miller County, and to provide for continued services by Miller County to the public. This Order is entered following consultation with health professionals and government officials.

NOW, THEREFORE I, CATHY HARDIN HARRISON, the duly elected County Judge for Miller County, Arkansas, by virtue of the authority legally vested in me, including Amendment 55, Section 3 of the Arkansas Constitution, as the Chief Executive of Miller County, promulgate the following Executive Order to take effect Thursday, April 2, 2020 at 2:00 p.m.

Public access to the Miller County Courthouse is restricted through April 30, 2020 to limit public exposure of/to COVID-19 and to protect the safety, health, and welfare of the citizens of Miller County as well as the employees.

Access to the Courthouse shall be restricted to County Employees, Court Employees, and Elected Officials having offices in, or conducting business in the respective building.

Persons having business with the Circuit or District Courts should contact the Court to determine whether or not there appearance for any court date is required, as the County will work with the Courts to coordinate any such mandatory appearances and provide reasonable accommodation for the same.

Any business to be conducted at the Miller County Courthouse should be conducted digitally, by phone, email, online or video conference absent an emergency. Should it be necessary that an individual has to conduct in person business or transactions at the Miller County Courthouse that cannot wait until after April 30, 2020, the individual shall contact the appropriate office to schedule a meeting before attempting entry into the Miller County Courthouse so that reasonable safeguards can be made for the County Employees and the general public.


Any individual travelling from outside of the State of Arkansas, especially from an area where COVID-19 is more prevalent, may be required to self-quarantine for up to fourteen (14) days before being allowed entry into the Courthouse. The County Judge and other elected officials shall take reasonable steps to safeguard employees from any individual coming into the Courthouse, including, but not limited to, taking the temperature of the individual prior to entry, the use of personal protective equipment and restricting access to certain portions of the building. Phone numbers and contact information for Courthouse Offices and Elected Officials can be found at www.millercountyar.com. Information regarding case filings can be found by utilizing the CourtConnect website at <http://caseinfo.arcourts.gov>. Deeds and real estate filings can be searched through Laredo, a subscription service, that can be accessed through www.fidlar.com; however, prior to setting up an account through Laredo, please contact the Miller County Circuit Clerk's Office for authorization. Documents can also be researched through the Tapestry program with Fidar.

Any business that is not time sensitive to be conducted at the Miller County Courthouse should be postponed until after April 30, 2020, if possible.

County Employees should report to their immediate supervisor regarding work schedules and whether the employee reports to their office or works from home. Any County Employee who is sick or feeling ill or has a household member who is sick or feeling ill should immediately contact their supervisor by phone before attempting to come to work. Any County Employee or other individual running a fever over 99.6 degrees will not be permitted entry into the Courthouse. All County Employees are encouraged to practice proper personal hygiene, including, but not limited to, frequently washing their hands and practicing social distancing.

These Orders may be modified or extended as additional facts and information become available regarding the COVID-19 virus.
