FINDINGS & ORDER

The formal charges of misconduct upon which this Findings and Order is based arose

from information filed by Steve Conley, a Tennessee-licensed attorney, who represented

Abernathy Motorcycle Sales, concerning the registration and collection on a foreign judgment in

Drew County, Arkansas.

Kenneth Alan Harper is an attorney licensed in 1989 to practice law in the State of

Arkansas and assigned Arkansas Bar Number 89022. Steve Conley, a Tennessee-licensed

attorney, represented Abernathy Motorcycle Sales in a Tennessee legal matter involving F&F

Custom Boats, LLC, an Arkansas-based corporation. On November 16, 2011, Abernathy

Motorcycle Sales was granted a judgment against F&F Custom Boats. Mr. Conley contacted

Mr. Harper in January, 2012 by telephone to inquire whether Mr. Harper would be willing to

represent Abernathy Motorcycles in registering the Tennessee judgment in Arkansas and

collecting on the judgment. Mr. Harper agreed to represent Abernathy Motorcycles.

Mr. Conley sent a package containing a letter dated January 3, 2012, a check for the

agree-upon retainer fee, and a copy of the Tennessee judgment. Mr. Conley thereafter wrote Mr.

Harper on March 7; March 26; May 16; June 4, and June 22, requesting information about the

status of the registration of the Tennessee judgment and collection efforts. Mr. Harper failed to

respond to each request.

Mr. Conley referred the matter to the Office on Professional Conduct. On August 8, 2012, the Office of Professional Conduct sent a letter to Mr. Harper, outlining the facts as provided by Mr. Conley. The Office requested that Mr. Harper contact Mr. Conley to discuss the status of the matter within ten days of the date of the letter. A copy of the letter was provided to Mr. Conley.

On August 21, 2012, Mr. Conley contacted the Office of Professional Conduct by fax to advise that he had not had contact from Mr. Harper within the time provided in the letter. On August 22, 2012, Stark Ligon, Executive Director, emailed a copy of the August 8, 2012, letter from the Office of Professional Conduct, and the August 21, 2012, letter from Mr. Conley to Mr. Harper at his email address, kah@harperlawfirm.com. Mr. Harper failed to respond to Mr. Ligon's email.

Mr. Harper filed a response to the Formal Complaint and admitted the allegations contained therein.

Upon consideration of the formal complaint and attached exhibit materials, the response, and the Arkansas Rules of Professional Conduct, Panel B of the Arkansas Supreme Court Committee on Professional Conduct finds:

- 1. Kenneth Alan Harper violated Rule 1.3 when he failed to register a Tennessee judgment as a foreign judgment with the Drew County Circuit Court. Rule 1.3 requires that a lawyer act with reasonable diligence and promptness in representing a client.
- 2. Kenneth Alan Harper violated Rule 1.4(a)(3) when he failed to keep his client, Abernathy Motorcycle Sales, a Tennessee client who was represented by counsel, Steve Conley,

informed about whether a Tennessee judgment had been registered in Arkansas. Rule 1.4(a)(3) requires that a lawyer keep the client reasonably informed about the status of the matter.

- 3. Kenneth Alan Harper violated Rule 1.4(a)(4) when he failed to respond to requests for information on March 7, 2012; March 26, 2012; May 16, 2012; June 4, 2012; June 22, 2012; and telephone calls from Steve Conley, attorney for Abernathy Motorcycle Sales, about whether a Tennessee judgment had been registered in the State of Arkansas as a foreign judgment. Rule 1.4(a)(4) requires that a lawyer promptly comply with reasonable requests for information.
- 4. Kenneth Alan Harper violated Rule 8.1(b) when he failed to respond to an August 8, 2012, letter from the Office of Professional Conduct requesting that he contact Steve Conley, attorney for Abernathy Motorcycle Sales, to advise of the status of the registration of the Tennessee judgment and when he failed to respond to an August 22, 2012, email from Stark Ligon, Executive Director of the Office of Professional Conduct, requesting that he respond to the request for information. Rule 8.1(b) requires that an applicant for admission to the bar, or a lawyer in connection with a bar admission application or in connection with a disciplinary matter, shall not fail to disclose a fact necessary to correct a misapprehension known by the person to have arisen in the matter, or knowingly fail to respond to a lawful demand for information from an admissions or disciplinary authority, except that this rule does not require disclosure of information otherwise protected by Rule 1.6.

WHEREFORE, it is the decision and order of the Arkansas Supreme Court Committee on Professional Conduct, acting through its authorized Panel B, that KENNETH ALAN HARPER, Arkansas Bar No. 89022, be, and hereby is, CAUTIONED; fined the sum of FIVE HUNDRED DOLLARS (\$500.00); directed to pay restitution in the amount of FIVE HUNDRED DOLLARS

(\$500.00) to Abernathy Motorcycle Sales; and, assessed costs in the amount of FIFTY

DOLLARS (\$50.00) for his conduct in this matter. The fine, restitution, and costs totaling ONE

THOUSAND AND FIFTY DOLLARS (\$1,050.00) shall be payable by cashier's check or

money order payable to the "Clerk, Arkansas Supreme Court" delivered to the Office of

Professional Conduct within thirty (30) days of the date this Findings and Order is filed of record

with the Clerk of the Arkansas Supreme Court.
